-Call to Order & Pledge of Allegiance:

The regular meeting of the Board of Supervisors was held at the Township Municipal Building. The meeting was called to order by the Chairperson, at 7:00pm. Those in attendance were, Lorreta Wilhide (Chairperson), Daryl Hull (Supervisor) and Lou Anne Bostic (Manager).

-Recognition of Public Requests:

-Cheryl Hengst, 1390 Jug Road presented her storm water concerns that she feels were created by the township in 2011 with the wearing course application on Jug Road. She states that water has been and continues to run onto her property. Mr. Hull stated that the township has met on site with the Public Works Director and the Township Engineer on several occasions and have made several changes to address the matter. Mr. Hull informed Ms Hengst that he feels she should contract with a private engineer and present the results to the Township. Ms Wilhide asked her to hold off until she talks with the Public Works Director.

-Karen Hostetter, representing the Red Land Community Library, presented information regarding the services that are provided to the residents of Conewago Township and requested that the Township consider provide funding to the library. The summer is filled with programs that are being provided to children and Conewago Township is the 2nd highest user of their services. Mr. Hull asked Ms Hostetter to provide a usage history to the Township for consideration during the 2020 Budget process.

-Curtis Knaub, 1595 Jug Road, voiced concerns regarding the increase in trash bills with the decrease in recycling services. Mr. Hull explained the recycling decrease is due to the Federal Government and their vendor changes. Mr. Knaub also stated that several large items remain curbside along Butter Road and are not being collected. The Board stated that service and billing concerns could be at issue.

-Cheryl Hengst, 1380 Jug Road, asked for clarification regarding the suggestion that she provide an engineering report for her stormwater concerns. Ms Wilhide would like to speak with the Public Works Director.
